## ARTICLES OF INCORPORATION OF SUNNY HOMES OF SW PLORIDA, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I - Namo

The name of the corporation is SUNNY HOMES OF SW FLORIDA, INC.
