The undersigned, being natural persons, do hereby act as incorporators in adopting the following articles of incorporation for the purpose of organizing a non-profit corporation pursuant to the provisions of the State of Florida Corporation Act;


- ARTICLE 1. The name of the Corporation is: INTERNATIONAL ASSOCIATION OF MIGRANTS, INC.
- ARTICLE 2. The period of existence shall be perpetual.
