**ARTICLES OF INCORPORATION**

The undersigned, being natural persons, do hereby act as incorporators in adopting the following articles of Incorporation for the purpose of organizing a non-profit corporation pursuant to the provisions of the State of Florida Corporation Act:

ARTICLE 1. The name of the Corporation is:  
INTERNATIONAL ASSOCIATION OF MIGRANTS, INC.

ARTICLE 2. The period of existence shall be perpetual.

ARTICLE 3. The purposes shall be:

- 1) To give social services to migrants living in State of Florida.
- 2) To provide them Legal Services.
- 3) To establish an Adult School where:
  - a) illiterate migrants can learn reading, writing and principles of mathematics.
  - b) individuals, families and communities have access to education and to different levels of training, and they can make better progress in all fronts.
- 4) To give Health Education and Nutrition Education.
- 5) To provide technical assistance in Housing to secure decent living conditions.
- 6) To establish an Association Hiring Hall that promotes a better and more productive working relationship between employers and employees, in an atmosphere of mutual respect and democracy.
- 7) To establish a Credit Union that helps migrant's financial security.

ARTICLE 4. Addresses of the Corporation are:

ARTICLE 5. Name of initial registered agent at such address is:

ARTICLE 6. The number of Directors constituting the board of directors shall be fixed by by-law.

ARTICLE 7. The officers of the Association shall be elected by the Board of Directors, and shall include the President, one or more Vice-Presidents, the Secretary, and the Treasurer. The Board of Directors shall also elect one or more employees for specific works.

ARTICLE 8. The names of the Initial Board of Directors are:  
Eugenia M. Aguirre, Maria Breniss and Gabriela E. Nunez.

ARTICLE 9. These articles may be amended in the manner authorized by law at the time of amendment.




