The undersigned incorporator for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be BREWER'S HAIRSTYLING, INC. The principal place of business of this corporation shall be as follows:
