

ARTICLES OF INCORPORATION

OF

ADVANCED BUILDING CONSTRUCTION AND DESIGN, INC.

The undersigned incorporator, for the purpose of forming a Corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

EFFECTIVE DATE

MAY 1 7 1995

The name of this Corporation is:

ARTICLE II - TERM OF EXISTENCE

The effective date of this Corporation shall be May 17, 1995. The Corporation is to exist perpetually.

ARTICLE III - PURPOSES

The purposes of the Corporation are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK
