The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is Leviticus Corporation and its principal office and mailing address is 1828 Grove Street, Sarasota, Florida, 34239.

ARTICLE II


Commencement of Corporate Existence
