In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE ONE

The name of the corporation shall be: DASOR INC.

ARTICLE TWO

The existence of the corporation shall begin on May 23, 1995

ARTICLE THREE

The maximum number of shares this corporation is authorized to issued is 7,500, all of which shall be common shares.
