ARTICLES OF INCORPORATION

OF

TRESTKO, INC.



The undersigned, being over 18 years of age hereby subscribes to and files these articles of incorporation to create a corporation under the laws of the State of Florida.

ARTICLE 1

The name of the corporation shall be Trestko, Inc.

ARTICLE 2

The aggregate number of authorized shares of capital stock of this corporation shall consist of seven thousand five hundred (7,500) shares of common stock, having a par value of ONE AND NO/100 DOLLAR (\$1.00) per share.

All the stock is payable in cash, property or labor or services at a just valuation fixed by the Board of Directors. Payment is not required at issuance.

ARTICLE 3

This corporation will commence immediately upon the filing of these articles of incorporation and will exist perpetually unless dissolved according to law.

ARTICLE 4

The initial registered office of this corporation is 80 SW 8th Street-Suite 2034, Miami, FL 33130. The initial registered agent at that address is David Solomon. Other offices and branch offices can be within or without the State of Florida. The mailing address is 80 SW 8th Street, Miami, FL 33130.

ARTICLE 5

This corporation shall have at least one director. The exact number can be specified by the stockholders from time to time. The stockholders can, by a majority vote, determine that the corporation be managed by the stockholders.

ARTICLE 6

No transaction between this corporation and a second party will be affected due to a director, officer of shareholder of this corporation having an interest in the second party. Directors can be counted in a quorum of this corporation notwithstanding their duality of interest.
