ARTICLES OF INCORPORATION
OF
21ST CENTURY SELF-HELP COMMUNITY DEVELOPMENT
CORPORATION

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be:

21st Century Self-Help Community Development Corporation

ARTICLE II
ADDRESS OF CORPORATION

The address of the principal office shall be:

ARTICLE III
PURPOSE

The purpose of the 21st Century Self-Help Community Development Corporation is to become a force for revitalization in the inner city neighborhoods where crime, violence and unemployment are the most concerns. Through the creation of the 21st Century Self-Help Community Development Corporation, the goal is to create housing, economic development, juvenile justice crime prevention programs and job training opportunities. However, the "Economic Empowerment" plan for the 21st Century Self-Help Community Development Corporation is to work toward filling this void in the following four areas of involvement: (1) Economic development through the creation of equity funds to promote business development; (2) neighborhood revitalization through the implementation of rehabilitation programs for housing; (3) creation of group homes to rehabilitate youthful offenders; and (4) job training.

ARTICLE IV
BOARD OF DIRECTORS

The corporation shall be composed of three (3) initial directors. The initial terms shall each be for a period of one (1) year. Thereafter, all initial directors and new directors shall be elected as provided in the By-Laws of the corporation. The three initial directors shall be:




