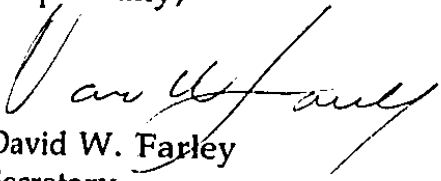

**ARTICLE ONE**

The name of the corporation is Fundraiser U.S.A., Inc.

**ARTICLE TWO**

The period of its duration is perpetual.

**ARTICLE THREE**

The purpose for which the corporation is organized is the transaction of any or all lawful business for which the corporations may be incorporated under the Florida Corporation Act.

**ARTICLE FOUR**

The aggregate number of shares of Common Stock which the corporation shall have authority to issue is 100 of the par value of the dollars (\$ 00.00) each.

#### ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$ 1,000.00 consisting of money, labor done or property actually received.

#### ARTICLE SIX

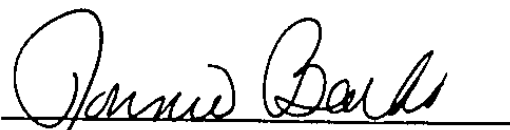
