ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The Corporation name is BENSADON IMPORT & EXPORT SERVICES, INC.

ARTICLE TWO DURATION

The duration of the Corporation is perpetual.
