**ARTICLES OF INCORPORATION**  
**OF**  
**ROBERT C. NUCCI, M.D., P.A.**

The undersigned, who is duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the Professional Corporation is ROBERT C. NUCCI, M.D., P.A.

**ARTICLE II**

**PURPOSE**

The purpose for which the Corporation is organized is to practice the profession of medicine.

**ARTICLE III**

**ELECTION UNDER PROFESSIONAL CORPORATION ACT**

The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

#### **ARTICLE IV**

##### **DURATION**

The duration of the corporation is perpetual.

#### **ARTICLE V**

##### **CAPITAL STOCK**

The number of shares the Corporation is authorized to issue is seven thousand five hundred (7,500), all of which shall be common shares with par value of One Dollar (\$1.00).

#### **ARTICLE VI**

##### **STATED CAPITAL**
