Pursuant to the provisions of Section 607.1403 of the Florida Business Corporations Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving the corporation:

1. The name of the corporation (the "Corporation") is KING PALM PARTNERS, INC.

2. The dissolution of the Corporation was authorized on the 1 day of August, 2002, by vote of the holders of at least sixty-six and two thirds percent (66-2/3%) of the outstanding common stock of the Corporation. The Corporation is authorized to issue only one class of common stock.

3. The number of shares of the stock of the Corporation cast for dissolution of the Corporation was sufficient for the approval of such dissolution.

4. These Articles of Dissolution shall be effective at 11:59 p.m. on December 31, 2002, the Articles of Dissolution having been filed and all fees paid to the Secretary of State.
