**ARTICLE I - NAME**

*The name of this corporation is  
ROSALYN RAE TALL, P.A.*

**ARTICLE II - DURATION**

*This corporation shall exist perpetually, commencing on the day of signing.*

**ARTICLE III - PURPOSE**

*This corporation is organized for the purpose of transacting any and all lawful business, including acting as trustee, and that of a Real Estate Agent.*

**ARTICLE XI - AMENDMENTS**


