

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is SPECIAL AMERICA'S BBQ, INC.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.




