ARTICLES OF INCORPORATION

OF

LOS BALKANES BAKERY AND RESTAURANT, INC.

The undersigned, acting as Incorporator of a Florida corporation under the Professional Service Corporation Act. Chapter 621 of the Florida Statues, and other laws of the State of Florida hereby adopts the following Articles of Incorporation for such Corporation:
