**ARTICLES OF INCORPORATION  
OF

I, **KENNETH J. MCAULEY**, being of legal age, do hereby sign these presents for the purpose of forming a corporation under the laws of the State of Florida authorizing the formation of corporations.

**ARTICLE I.**

The name of the corporation shall be:

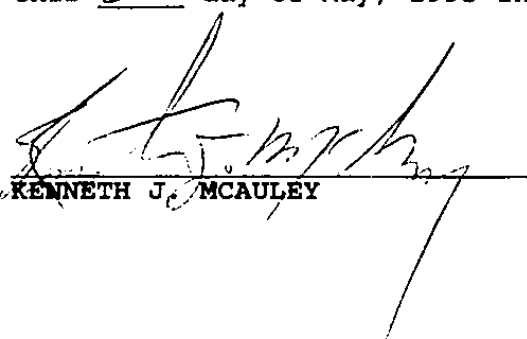

ARTICLE X.

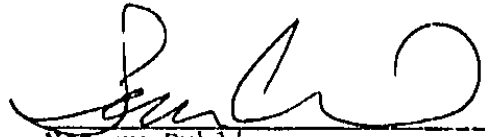

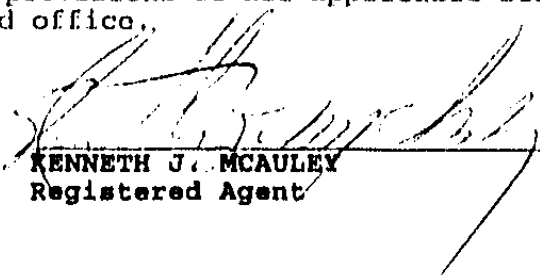
