The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

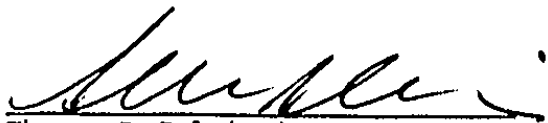
- ARTICLE I:** The name of this corporation is:

- ARTICLE II:** The principal office and mailing address of the corporation shall be: 3445 N.W. 7th Street, Miami, Florida 33125-4013
- ARTICLE III:** This professional corporation is organized pursuant to Chapter 621 of the Florida Statutes for the purpose of rendering legal services and to engage in such other activities incidental thereto as may be permitted by law.

- ARTICLE VIII:** The corporation shall indemnify its officers, directors, employees and agents to the fullest extent permitted by law.
- ARTICLE IX:** The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or in any amendment

hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE X:

The corporation shall commence corporate existence on June 1, 1995 in accordance with Florida Statutes, Section 607.0203(1).

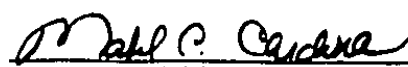
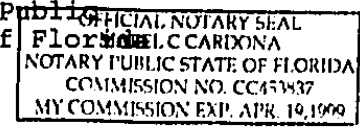

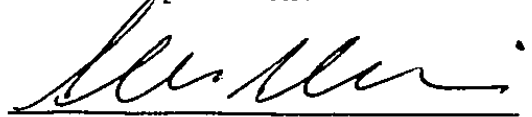
