

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF COMMUNITY BANK OF MANATEE

Pursuant to the provisions of Sections 607.0704 and 607.1006, Florida Business Corporation Act (the "Act"), COMMUNITY BANK OF MANATEE, a Florida banking corporation (the "Bank"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Amendment

Paragraph A of Article III of the Articles of Incorporation of the Bank is hereby amended and restated in its entirety as follows:

"A. <u>Classes of Stock</u>. The Bank is authorized to issue 20,000,000 shares of common stock, par value, \$1.00 per share (the "<u>Common Stock</u>"), and 2,000,000 shares of preferred stock, par value to be assigned according to class (the "<u>Preferred Stock</u>")."

Approval of Amendment

The Amendment was approved and adopted by written consent of the holders of a majority of the outstanding common stock of the Bank on December 21, 2009. The holders of the common stock are the only voting group entitled to vote on the amendment, and the approval of the amendment by he holders of a majority of the common stock was sufficient to approve such amendment under the Act and the Bank's Articles of Incorporation and Bylaws.

Effective Date of Amendment

The Amendment shall become effective on the date these Articles of Amendment are filed with the Department of State of the State of Florida.
