ARTICLES OF INCORPORATION

The undersigned Incorporator(s) subscribing to these Articles of Incorporation, being competent to contract, hereby form(s) a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: Exogenix, Inc., and its initial mailing address and the initial address of the Corporation's principal office shall be: 1008 Cameo Crest Lane, Valrico, Florida, 33594.

ARTICLE II

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida.

This Corporation shall have all powers given corporations under the Laws of the State of Florida.

ARTICLE III

The maximum shares of stock that this Corporation is authorized to have outstanding at any one time shall be ten thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00).

This indemnification article shall specifically not apply to persons or entities who are or were employees or agents of the Corporation, but who are not or were not directors or officers of the Corporation.

This Corporation is to exist perpetually.

ARTICLE VIII

These Articles of Incorporation may be ammended in the manner provided by law.

ARTICLE IX
