The undersigned Incorporator(s) subscribing to these Articles of Incorporation, being competent to contract, hereby form(s) a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: Exogenix, Inc., and its initial mailing address and the initial address of the Corporation's principal office shall be: 1008 Cameo Crest Lane, Valrico, Florida, 33594.

ARTICLE II

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida.

This Corporation shall have all powers given corporations under the Laws of the State of Florida.

ARTICLE III

The maximum shares of stock that this Corporation is authorized to have outstanding at any one time shall be ten thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00).

ARTICLE IV

The name of the initial Registered Agent is Allen D. Seevers and the street address of the initial registered office of this Corporation is 1008 Cameo Crest Lane, Valrico, Florida, 33594. The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE VI

To the fullest extent permitted by Chapters 607 and 617 of the Florida Statutes (hereinafter referred to as the "statutes"), as the same may be from time to time amended, but subject to all restrictions set forth therein, the Corporation shall indemnify, hold harmless, and advance expenses to, as defined in the statutes, any person, his or her heirs, personal representative, executor, administrator or guardian who was or is a party to any proceeding, as defined in the statutes, by reason of the fact that he or she is or was a director or officer of the Corporation, against liability as defined in the statutes, expenses as defined in the statutes, and amounts paid in settlement incurred in connection with such proceeding, including any appeal thereof. This indemnification article shall specifically not apply to persons or entities who are or were employees or agents of the Corporation, but who are not or were not directors or officers of the Corporation.

ARTICLE VII

This Corporation is to exist perpetually.

ARTICLE VIII

These Articles of Incorporation may be amended in the manner provided by law.

ARTICLE IX

Pursuant to the provisions of Chapter 607, Florida Statutes, this Corporation shall begin in existence upon filing of these Articles of Incorporation with the Secretary of State.
