ARTICLES OF INCORPORATION

OF

MELODY LANE ENTERTAINMENT, INC.

The Undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name and principal address of the corporation is MELODY LANE ENTERTAINMENT, INC., at 4815 Grapeville Way, Davie, Florida 33331.

DURATION

The term of existence of the corporation is perpetual.
