# ARTICLES OF INCORPORATION OF SUPERIOR PROCESS & INVESTIGATIVE SERVICES, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

# ARTICLE I

#### NAME

THE NAME OF THE CORPORATION IS: SUPERIOR PROCESS & INVESTIGATIVE SERVICES, INC., a Florida Corporation which is not a member of any affiliated group.

# ARTICLE II

#### DURATION

The term of existence of the corporation is perpetual.

# ARTICLE III

#### **PURPOSE**

The general purposes for which the corporation is organized are:

- 1. To engage in the business of service of process, investigations of individuals and background checks for private individuals and employers and to do all of the things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing and all related activities incidental to same.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

#### CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is ONE THOUSAND SHARES (1,000). Such shares shall be of one class, and shall have a par value of SEVEN DOLLARS (\$7) per share. All issued stock shall be held of record by not more than THIRTY (30) shareholders. Stock shall be issued or transferred only to natural persons for money and other property. In addition, no stock shall be issued or transferred to a non-resident alien.

# ARTICLE V

# PREEMPTIVE RIGHTS GRANTED

Stockholders of the corporation shall have preemptive rights upon stock issuance.

# ARTICLE VI

#### REGISTERED OFFICE
