

ARTICLES OF INCORPORATION OF

EMPLOYMENT NETWORK PRODUCTIONS, INC.



The undersigned, for the purpose of forming a Corporation .
under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this Corporation is: EMPLOYMENT NETWORK PRODUCTIONS, INC. The principal place of business of this Corporation is: 88 Santa Monica Ave., Royal Palm Beach, Florida 33411, which is the same as the registered office of this Corporation.

ARTICLE II

This Corporation shall have perpetual existence commencing on the filing of these Articles.

ARTICLE III

PURPOSE

The general purposes for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purposes of the Corporation or necessary or desireable in order to accomplish them.
- c. To engage in the operation of a business dedicated to the promotion of business trade fairs and to carry on any business necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is Five Thousand (5,000) Shares of

common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1,00) per share.
