ARTICLES OF INCORPORATION

OF

ARTICLE I

EFFECTIVE DATE MAY 2 2 1995

NAME

The name of this corporation shall be:

ARTICLE II

TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III

PURPOSE
