

ARTICLES OF INCORPORATION

ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS YES WINDOW TINTING, CORP. and the mailing address is 1800 West 68 Street, Hialeah, Fl 33014.

ARTICLE II

DURATION

This corporation shall have a perpetual existence, unless dissolved according to law.
