ARTICLES OF INCORPORATION
OF

ARTICLE ONE

The name of the corporation is:
SKYWAY TECHNOLOGY GROUP, INC.

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The corporation may engage in any activity or business permitted under the laws of the United States of America and Florida, and to carry out such business in any state, territory, district or possession of the United States, or any foreign country, to the extent that such purposes are not forbidden by the laws of such state, territory, district or possession of the United States, or by such foreign country.

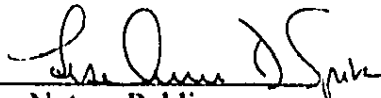
