ARTICLES OF INCORPORATION

OF

Commserve Management, Inc.

ARTICLE I

The name of the Corporation is Commserve Management, Inc.

ARTICLE II

The Corporation is organized for the purpose of transacting any-and all business for which corporations may be formed under Chapter 607 of the Florida Statutes, as amended from time to time. \Box

The Corporation elects not to be governed by Florida Statute Section 607.0902, as amended from time to time, relating to control share acquisitions.

ARTICLE IX

The Corporation elects not to be governed by Florida Statute Section 607.0901, as amended from time to time, concerning affiliated transactions.

ARTICLE X
