ARTICLES OF INCORPORATION

Solve Color NEW ZEALAND DAIRY SERVICES (LATIN AMERICA) INC

EFFECTIVE DATE The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, by and under the provisions for the formation, liability, rights, privileges and immunities of a corporation for profit, which incorporation shall become effective June 1, 1995.

ARTICLE I

The name of the corporation shall be:

NEW ZEALAND DAIRY SERVICES (LATIN AMERICA) INC.

ARTICLE II

The general nature of the business proposed to be transacted and carried on, and the objectives and purposes of the corporation, are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:


