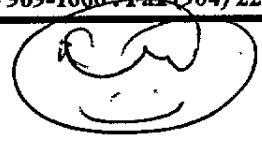

FIRST: The name of the corporation is Cash Solution, Inc. (the "Corporation").


SECOND: The Articles of Incorporation of the Corporation were filed on May 24, 1995.
