ARTICLES OF INCORPORATION  
OF  
NATURE UNLIMITED, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a Domestic Corporation under the laws of the State of Florida pursuant to the Section 607.164 Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be:

NATURE UNLIMITED, INC.

ARTICLE II: ADDRESS

The initial address of the principle office of this Florida corporation is:

ARTICLE III: PURPOSE

The general nature of the business to be transacted by this corporation is:

Landscaping, lawn care, pressure cleaning and  
general maintenance

This corporation shall engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV: CAPITAL

The amount of capital with which this corporation will begin business shall not be less than Five Hundred Dollars (\$500.).

ARTICLE V: CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is:

7500 Shares Common, Par Value \$ 1.00

ARTICLE VI: PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale of any new stock of this corporation, shall have the right to purchase his/her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. Every shareholder will also have the right of first refusal upon the offer for sale of existing shares of stock.

ARTICLE VII: DURATION

This corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles of Incorporation, unless sooner dissolved according to law.

ARTICLE VIII: DIRECTORS

This corporation shall have one director initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but there shall never be less than one director nor more than five.


ARTICLE XI: INDEMNIFICATION

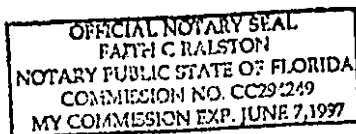


