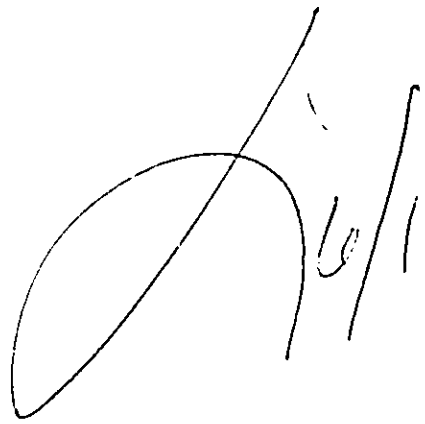

Article 2: DURATION: Term of existence of the corporation is perpetual.

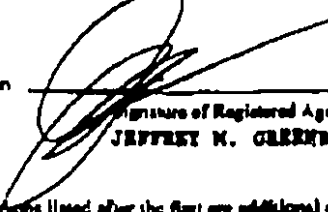

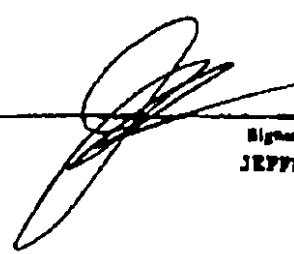
