The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I
NAME OF CORPORATION

The name of this corporation shall be Personal Motorcycle Safety, Inc.

ARTICLE II
GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be for profit.

1. The purpose of this corporation is to provide motorcycle rider education to the general public together with all aspects relevant thereto.
2. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 608, Florida Statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality of the foregoing, this corporation does not conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, fraternal benefit society, state fair or exposition business.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any time is Five Hundred (500) shares of One Dollar (\$1.00) per share.

ARTICLE IV
INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall be at least Five Hundred dollars (\$500.00).

ARTICLE V
TERMS OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE VI
ADDRESS OF CORPORATION

The initial street address of the principal office of this corporation in the State of Florida will be 1213 Noble Place Orlando, Florida 32801.

The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VII
BOARD OF DIRECTORS

The initial number of Directors of this corporation shall be one director

(1). The number of directors may be increased or diminished from time to time by the By-Laws adopted by the stockholders, but shall never be less than (1) one. 
