ARTICLES OF INCORPORATION OF WATERSIDE HOME BUILDERS, INC.

The undersigned, acting as incorporator of a Floridan's corporation under the Florida Business Corporation Act, Chapter 6070, of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I NAME

The name of the Corporation is WATERSIDE HOME BUILDERS, INC.

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of Florida.
