ARTICLE I

The name of the corporation is Demark Consulting, Inc. The principal business address or mailing address of the corporation is: 633 N. Ocean Blvd., Deerfield Beach, Florida 33441.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is organized for the purpose of the transaction of any and all lawful business for which corporations may be incorporated, pursuant to Chapter 607, Florida Statutes, known as the Florida Business Corporation Act.

ARTICLE IV

The corporation is authorized to issue only one class of stock, which shall be designated "common shares". The total number of shares which the corporation is authorized to issue is 1,000.

ARTICLE V

The corporation's issued shares shall be held of record by not more than thirty-five (35) persons. This corporation is a close corporation.

ARTICLE VI

No distinction shall exist between the shares of the corporation or the holders thereof.

ARTICLE VII

The street address of the initial registered office of the corporation is 500 East Broward Boulevard, Suite 1950, Fort Lauderdale, Florida 33394, and the name of the initial registered agent of the corporation at that address is Mark R. Wysocki.

ARTICLE VIII

The corporation shall have initially one (1) director. The number of directors may be either increased or decreased from time to time as determined by the By-Laws.

Any By-Law adopted by the shareholders may provide that one or more provisions thereof shall not be altered, amended or repealed by the Board of Directors, in which case such provisions may be amended, altered or repealed only by the shareholders.

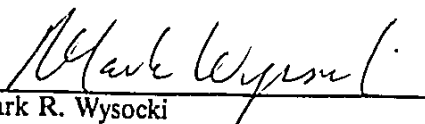
ARTICLE XI

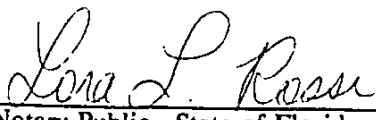

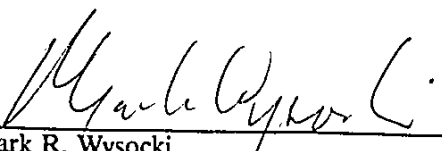
