The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Continental Advertising Corporation (the "Corporation").

Except for any person who is or was a director or officer of the Corporation, or any person who is or was serving at the request of the Corporation as a director of officer of another corporation, no employee or agent of the or officer of another comporation, no employee or agent of the Corporation may apply for indemnification or advancement of expenses to any court of competent jurisdiction.
