ARTICLE I

The name of the Corporation shall be:

TERM OF EXISTENCE

ARTICLE III

PURPOSE

ARTICLE IV


CAPITAL STOCK

This Corporation is authorized to issue par value common stock as described below, and none other:

EFFECTIVE DATE

The corporation shall become effective as of the filing of these Articles with the Secretary of State, Division of Corporations.
