The Undersigned, desiring to incorporate a business corporation under the provisions of the Florida General Corporation Act does hereby certify:


1. The name of the Corporation is Hard Parts Inc.

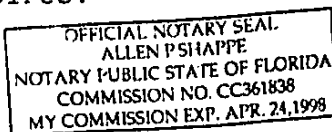


