**ARTICLES OF INCORPORATION**

KNOW ALL MEN BY THESE PRESENTS, that Richard K. Allison, desiring to establish a business corporation dedicated to moving and servicing mobile homes, and desirous of becoming incorporated under the laws of the State of Florida, does hereby initiate these Articles of Incorporation according to the provisions of the *Florida Business Corporation Act*.

**ARTICLE 1**  
**Name**

- § 1.01 The name of the Corporation shall be Allison Mobile Home Service, Inc.

**ARTICLE 2**  
**Purposes**

- § 2.01 The purposes for which the Corporation is organized are strictly within the bounds of State and Federal requirements for business corporations. Allison Mobile Home Service, Inc., shall establish a business of moving, setting up, and servicing mobile homes, as well as any other lawful purposes deemed necessary and proper by the stockholders and directors, and shall undertake any all legal activities permitted by the *Florida Business Corporation Act*.
- § 2.02 This corporation reserves the right to exercise and pursue any and all powers prescribed for business corporations by the *Florida Business Corporation Act*.

**ARTICLE 3**  
**Duration**

- § 3.01 The duration of the Corporation shall be perpetual, unless sooner dissolved in accordance with the Laws of the State of Florida pertaining to the dissolution of business corporations.

**ARTICLE 4**  
**Capitalization and Shares of Stock**

- § 4.01 The aggregate number of shares which the Corporation shall have authority to issue is 100 shares of common stock with a par value of \$10 each, for a total of \$1,000 in par value.
- § 4.02 There shall be only one class, common, which stock and ownership thereof shall be subject to the corporate bylaws and the restrictions on transfer of stock noted on said stock certificates.
- § 4.03 The initial stock will be held by Richard K. Allison and wife, Cathy A. Allison, in common and with joint rights of survivorship.

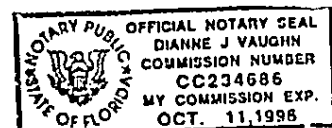

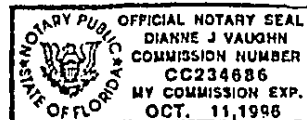
