


ARTICLE IX-INDEMNIFICATION

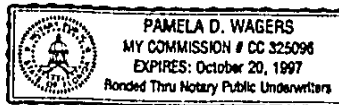
