ARTICLES OF INCORPORATION FOR CAUSEWAY SERVICE STATION, INC.

MAURICE BENCHABAT _baing of legal age, do hereby sign these presents for the purpose of becoming a Corporation under the Laws of the State of Florida authorizing the formation of Corporations.

ARTICLE I

The name of the Corporation shell be: CAUSEWAY SERVICE STATION, INC.

ARTICLE 11

- A. The general nature of the business and the objects and purposes to be transacted and cerried on ere to do any and all of the things hersin mentioned, as fully and to the same extent as natural persons might or could do, VIZ: SALES and to do any and all things and matters necessary and apportaining thereto and further enabling this Corporation to engage in any activity or business permitted under the Laws of the United States of America and of the State of Florida.
- To build, construct and alter houses, buildings and structures of whatever nature and kind; to develop real property generally; to purchase, manufacture, acquire, hold, own, lease, sell, assign, transfer, invest in, trade in, deal in goods, wares, merchandise, real and personal property of every kind and description.
- C. To conduct all types of business and operations; to have one or more offices and hold, purchase, mortgage, lease, dispose of, deal in and convey real and personal property without restrictions in this State and in any other of the several States,

territories, possessions and dependencies of the United States.

- O. To engage in, render or carry on, any service or other business as principal or agent, with powers to let contacts for any such service or product; and to make and carry out contracts of every kind and nature that be conducted to the ecoemplishment of any purpose of this corporation.
- E. To acquire by purchase or otherwise, for investment or resale, and to own, improve, operato, subdivide, lease, mortage, sell and otherwise deal in, for cash or credit, by conveyance, agreement for deed, or other lawful instrument, real estate or mixed property located in the State of Florida or elsewhere, and generally to deal in and traffic as owner or agent in real estate, personal and mixed property, and any interest or estate thorsin, and to create, own, lease, sell, operate or deal in freehold and leasehold estates of any and all nature whatsoever and to be an investor in real, mixed, and/or personal property; to grant, sell, and otherwise deal in franchises and licenses.
- F. To factor, lend or borrow money, be a surety, and to execute and deliver, accept, take and receive notes, bonds and debentures or other evidences thereof, and mortgage, trust deed, pledges or other securities for payment of same.
- G. To act as agent, broker, or attorney-in-fact for any persons, firms or corporations in buying, selling and dealing in real or parsonal property or services of whatsoever kind or nature and in managing and conducting any legal actions, proceedings and business relating to any of the purposes herein mentioned or referred to.
- H. To acquire, hold, undertake and fully exploit the good will, property, rights, franchises, assets of every kind and the liabilities of any person, firm, association or corporation either wholly or partly; and to pay for the same in cash, stocks or bonds of the Company or otherwise.
- I. In any manner to acquire, enjoy, utilize and to dispose of patents, copyrights and trademarks, and any license or other interest therin and thereunder.

- Decome interested in, deal in and with, invest in, hold, pledge, sell, mortgage, lend money on, exchange or otherwise dispose of or turn to account or realize upon as owner, agent, broker or factor, all forms of securities, including stocks, bonds, debmentures, mortgages, notes, evidencing shares of or interest in common law trusts, trusts and trust estates or associations, destrictes of trust or beneficial interests in trusts, mortgages, contracts and other instruments, securities and rights; to investigate and report with respect to; and to undertake, carry on, aid, assist or perticipate in the organization, liquidation or reorganization of financial, commercial, mercentile, manufacturing, industry or other business concerns, firms, associations and corporations to institute, participate in or promote commercial merchandise financial and industrial enterprises and operations.
- K. To berrow money and contract debts when necessary in the purchase of or acquisition of real, personal and intengible property, business rights or franchises, or for additional working capital or for any other object in or about its business or affairs and without limit as to amount; and to secure the payment of money in any lawful manner.
- L. To enter into any partnership, limited or general, as Limited or General Partner, or both, and to enter into any other arrangement fer profit sharing, union or interest, or cooperation, with any corporation, association, partnership, syndicate, entity, person or governmental, municipal or public authority in the carrying on of any business which this corporation is authorized to carry on, or any business or transaction decomed necessary, convenient or incidental to carrying out any of the purposes of this corporation.

To purchase, hold, sell and transfer shares of its own capital stock; subject, however, to such limitations as may be provided by law; capital stock owned by the corporation shall not be voted upon directly or indirectly, nor counted as outstanding for the purpose of any stockholders, quorum or vote.

- O. To exercise all of the powers which are now or may hereafter be conferred upon corporations generally by the Laws of the State of Florida.
