ARTICLE I - NAME



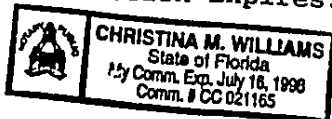



