ARTICLES OF INCORPORATION

FOR

ARTICLE I - NAME

The name of the corporation is INFO POWER 2000 INC.

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the law of the United States and of the state of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of Common Stock at \$1.00 par value

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of an new stock of this corporation of the same kind, class or series that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII - INITIAL BOARD OF DIRECTORS
