ARTICLES OF INCORPORATION

OF

ARTICLES I - NAME AND ADDRESS

The name of this corporation is JEC Air Conditioning Inc.  
The address of the principal office and the mailing address of this corporation is 2900 Southwest 20th Street Miami, Florida 33145-2340.

ARTICLES II - PURPOSE

This corporation is organized for the purpose of transaction any and all lawful business.

The aggregate number of shares which this corporation shall have authority to issue is One Hundred (100) shares of common stock, all of which are to have a par value of One Dollar (\$1.00) per share. Every shareholder, upon the sale for cash of any unissued or treasury shares of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done


