The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**FIRST:** The name of the corporation is **DORAL CENTER, INC.** (the "Corporation"):

**SECOND:** The street address of the initial principal office of the Corporation is 1836 West 23rd Street, Miami Beach, Florida 33140.

**THIRD:** The Corporation is authorized to issue 1,000 shares of common stock, par value \$1.00 per share.

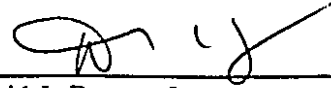
