I, the undersigned, hereby make, subscribe, acknowledge,
and file these Articles of Incorporation for the purpose of
becoming a corporation under the laws of the State of Florida.

ARTICLE I

IDENTIFICATION

The name of this corporation is REFERENCE MEDICAL
SUPPLY, INC..

ARTICLE II

DURATION

The corporation shall have perpetual existence which
shall commence at the date of the filing of these Articles with the
Secretary of State.

ARTICLE III

PURPOSES

The corporation may engage in any activity or business
permitted under the laws of the United States and of the State of
Florida.

ARTICLE IV

AUTHORIZED SHARES

The capital stock of this corporation shall consist of
3,000 Shares of Common Stock of One Dollar (\$1.00) par value each,
all or part of said stock to be issued from time to time as may be
determined by the Board of Directors. There shall be no preemptive
right granted to the stockholders with respect to the shares of the

corporation. On dissolution or liquidation of the corporation, holders of the stock shall be entitled to distribution ratably as their holdings may appear upon the stock record of the corporation.

ARTICLE V

REGISTERED AGENT AND OFFICE

The initial registered agent of this corporation and his address is as follows: JORGE OCHOA, 8924 SW 25TH STREET MIAMI, FL 33165. The principal office is the same.

ARTICLE VI

BOARD OF DIRECTORS

1. The number of Directors of this corporation shall not be less than one (1) nor more than five (5).

ARTICLE VII

INCORPORATOR
