ARTICLES OF INCORPORATION
OF
PACIFIC RIM HOLDINGS, INC.

The undersigned subscribers, being natural persons to contract, and for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation shall be PACIFIC RIM HOLDINGS, INC.

ARTICLE TWO

This corporation shall have a perpetual existence unless sooner dissolved according to law, and shall commence corporate existence upon the filing of these Articles by the Department of State.

ARTICLE THREE

This corporation is organized for the purpose of transacting, conducting, carrying on, operating, and engaging in the business of international trade and investments, the participation in international joint ventures, consulting and any and all subsidiary, necessary, ancillary, or convenient activities for the purposes of carrying out and effecting the objectives of the corporation, and in respect thereto, and to transact and engage in any activity or business permitted under the Laws of the State of Florida, and of the United States of America.

ARTICLE FOUR

This corporation is authorized to issue One Million (1,000,000) shares of stock at no par value per share which shall be designated "Common Stock".

ARTICLE FIVE

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds shall have the right to purchased his pro rata share thereof (as nearly as may be done without the issuance of fractional shares), at the price at which it is offered to others.

ARTICLE SIX

The street address of the initial registered office of this corporation is 2780 B Park Drive, Clearwater, Florida, 34623, and the name of the initial registered agent of this corporation is Michael J. McKinney, whose office and mailing address is the same as the initial registered office address. *Principal address*

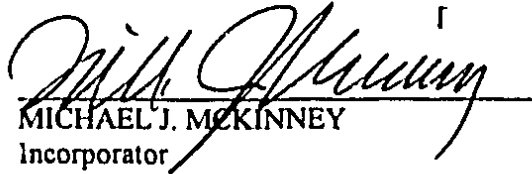

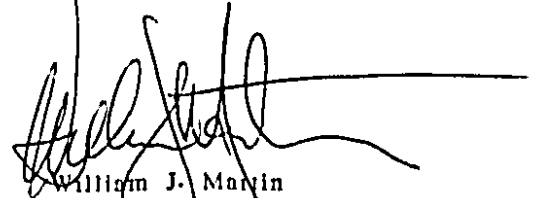

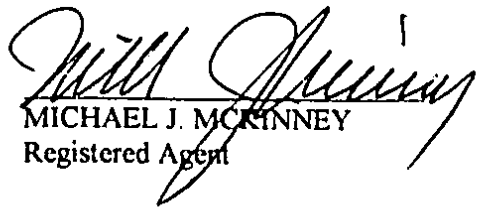
