OF

PALMETTO COMMONS CORPORATION

Article I

Name

The name of the corporation is PALMETTO COMMONS CORPORATION.

Article II

Duration

This corporation shall have a perpetual existence.

Article III

Purpose

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, as amended.

Article IV

Indemnification

Bylaws

The bylaws may be adopted, altered, amended or repealed by either the shareholders or the Board of Directors, but the Board of Directors may not amend or repeal any Bylaw adopted by shareholders if the shareholders specificarly provide such Bylaw is not subject to amendment or repeal by the directors.
