**ARTICLES OF INCORPORATION**

**SPENCER & PIERCE, INC.**

The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is

**SPENCER & PIERCE, INC.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Florida Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 100 shares of No Par Value voting common stock which shall be designated "Voting Common Stock" and is also authorized to issue 100 shares of No Par Value non-voting common stock which shall be designated "Non-Voting Common Stock". Except for voting rights, the stock is identical.

**ARTICLE V - PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale for cash or equivalent of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof even if it requires the issuance of fractional shares, at the price at which it is offered to others.

**ARTICLE VI - INITIAL REGISTERED AGENT**


