ARTICLE I - NAME

The name of the corporation is:

TO THE POINT, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized to transact under Chapter 607, Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of One Dollar (\$1.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - PRINCIPAL PLACE OF BUSINESS

The principal place of business of the corporation shall be at 3380 BANKS RD. SUITE 206, MARGATE, FLORIDA 33063, with the privilege of having additional offices at other places within or without the State of Florida and within or without the United States of America.

ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is: 3380 BANKS RD. SUITE 206, MARGATE, FLORIDA 33063 and the name of the initial Registered Agent of this corporation at that address is: MARK KAFKA.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS


ARTICLE XI - INDEMNIFICATION


